More than thirty members of LWVCCA gathered on the evening of May 17th to mark the fifty ninth annual meeting of our league, to elect a new slate of officers, to approve the budget and to vote on our local program for the coming year. And yes, to enjoy an excellent buffet. Guest speaker for the evening was Alisa Galazzi, the CEO of Housing Assistance Corporation (HAC), shown above.

In her President's report, Scotti Finnegan summarized the events and forums held throughout the past year and expressed appreciation to all members for their efforts, with particular thanks this year to Karen Mazza (Youth Service), Renate Sands (Legislative) and Anita Rogers (Voter Service) and their committees. She noted that the League's nonpartisan position can be complicated, but that in total it enables us to align with other groups and organizations in working for a better country.

The Local Program for the coming year, as approved by the membership, will concentrate first and foremost on **Voter Service**: automatic voter registration, get-out-the-vote, arranging candidate events; We will also continue to monitor **County Government**...work to increase the participation of youth in voting, support implementation of a **civics** component in our schools...focus on **opioid addiction** and **mental health** issues...support regional approaches to wastewater management and encourage community education re **environmental concerns**. YOUTH SERVICE COMMITTEE REPORT

BREAKING NEWS FROM LWVMA -- HOUSE PASSES S.2375!

On Friday, May 31st, the Massachusetts House voted 151-0 to pass S.2375, one of the nation's most innovative civic education bills. S.2375 provides funding for professional development of teachers...the opportunity for students to participate in civic projects and naming civic education as a priority for school districts. LWVMA has been an active member of the Mass. Civic Learning Coalition which championed the bill. The State League expressed its thanks to LWVMA specialists Karen Mazza and Terry Yoffie for their input on key aspects of the bill, to coalition partners for their hard work *and to all League members who contacted their legislators in support.*

The bill will now be taken up for consideration by a conference committee -- and if consensus is reached, it will be sent to the Governor's desk.

CAPE STUDENTS SCORE HIGH IN VIDEO COMPETITION

We are pleased to announce that a team from the Nauset Regional High School was awarded Second Place in the LWV "Get In the Game and Vote!" high school video competition for their entry, "Change". Team members who submitted their 30-second video are Zichen Zhou, Skyeler Sandison, Leah Baker, Nick Qvarnstrom, Romell Brown, and Eli Patrick. As Second Place winners, the team will receive \$250.

In addition, **Liam Mawn from Monomoy Regional High School** was recognized for his entry, "Youth Voting Rap". And the three-person team of Jack Our, Jordan Our, and Isabel Merl, also from Nauset, were recognized for their entry "I can Vote Clearly Now".

Congratulations to all of these students for their efforts and compelling messages! The winning videos can be viewed from the LWVMA website, lwwma.org.

The Youth Service Committee had encouraged Cape Area student participation by sending contest details with a cover letter to each Cape high school principal. We also linked the purpose of this contest to the **workshop** our committee sponsored in October on the development of student-led plans to encourage students to register to vote.

In the same letter, we reminded the schools that registering students to vote is only half the battle. We need to encourage students to actually vote. The October workshop, the Voter Information Sheets that we gave to each school for distribution to seniors, and this video contest marked three related activities our committee sponsored to expand the youth vote.

Youth Service Report cont.

We have now received feedback from two of the four high schools that participated in the workshop about the success of the strategies they used to register students. *Mashpee HS registered 60 seniors and Dennis-Yarmouth Regional HS registered approximately 125 students!* Both schools indicate they will do this again next year and will involve students in leading the effort.

We closed this year by sending information to Cape civics teachers announcing a grant opportunity for **student-led projects on gun violence prevention**, sponsored by the coalition of 11 non-profit groups including LWVCCA, which participated in the gun violence movie and discussion at the Cape Cinema in April. All of these activities, along with our participation in lobbying legislators to support S.2375, have made this a most productive year. Supporting the civic engagement of youth is a worthwhile endeavor for our organization.

LEGISLATIVE COMMITTEE REPORT

From Renate Sands

The following bills were discussed at the Legislative Breakfast. Below is an update of those bills.

Extreme Risk Protection

The bill H.3610, Extreme Risk Protection Order (ERPO), would permit temporarily removing firearms from dangerous or suicidal individuals has been ordered to a third reading.

Civics Education

The Civics Education bill (S.2375) has passed the Senate and the House. It is currently in conference committee. (See article above on Youth Service Committee.)

Automatic Voter Registration

Automatic Voter Registration (H.4320) is in the House Committee on Ways and Means and needs to be brought to the floor for a vote.

Pilgrim

Only one of the four Pilgrim related bills has moved forward during this legislative session. Filed by Representative Peake (H.2472) has passed both houses and is currently in the Jt. Committee on Health Care Financing. The bill expands the state's definition of the emergency planning zone from 10 miles around the plant to include unique geographical areas like Cape Cod, the Islands and Cape Ann.

Affordable Housing

The Affordable Bonding Housing Bill (H.675/H4131) has been ordered to a third reading.

Short Term Rental

The Short-Term Rental Tax (S2381/H4327) has passed to be engrossed.

Criminal Justice

The Criminal Justice Omnibus Bill (S.2371/H.4327) has been signed by the governor.

The Safe Community Act was not brought up at the Legislative Breakfast since it appeared not to be progressing. Below is the latest effort to incorporate some of the major issues into the budget process.

Safe Communities

The Senate budget process may be a pathway to adopt three key provisions of the Safe Communities Act, a bill which never made it through the legislative process. Budget amendment #1147 would (1) defund the 287g program thereby ending collaboration between sheriffs and ICE (2) limit when local police can ask about immigration status and (3) ensure that immigrants in police custody know their legal rights.

BARNSTABLE COUNTY UPDATE

An important public meeting of the Barnstable County Assembly of Delegates will be held on Wednesday, June 6 at 4:45pm. The discussion will be on proposed County Ordinance 18-09, to provide funding for a grant to promote regional clean water efforts by a transfer and appropriation of \$185,000 from the Special Projects Reserve Fund.

LWVCCA has a long history of monitoring the activities of both the County Board of Commissioners and the County Assembly of Delegates. The Commissioners meet every Wednesday at 10am, the Assembly meets every other Wednesday 4 in the afternoon. Thus six meetings a month.

We are again seeking volunteers who are willing to attend at least one of these meetings each month. If everyone helps, each member would need to attend two or perhaps three meetings each year.

In the next few months, you will receive a sign-up sheet. Hope you can help!
