**Statement to the  
County Commissioners of Barnstable County  
April 6, 2011**

I am Judy Thomas, president of the League of Women Voters of the Cape Cod Area. I thank you for this opportunity to offer our some of our thoughts on the County and its Charter to you.

The League of Women Voters of the Cape Cod Area has been interested in and followed the county government for years. Our own League program, adopted annually, always includes “County Government – monitoring” among its priority items.

Today, on behalf of the Board of the League and its county government committee, I’m pleased to offer these comments based on our study and numerous observations.

1. We strongly support a strong regional government and see it as an instrument of the people which can and does provide many important services to the people of the Cape. Sadly, due to under reporting and communication, a great majority of our residents are not even aware a county government exists.
2. We believe the County is uniquely situated to remind and assist the fifteen towns of the Cape in seeing the “big picture.” We see a need for strong voices at the County level to help the fifteen towns recognize and accept their interconnectedness. This recognition includes not only the benefits of, but also the necessity of, regional approaches to what are truly regional problems – problems not able to be solved effectively, efficiently or economically by individual town responses.
3. We support the recent questioning done by both individuals and organizations as to the current effectiveness of our county charter. The charter is now more than 24 years old. Previous five year charter reviews have done well at various “house-keeping” chores and minor revisions. But in nearly twenty-five years, times have changed. The County’s population has grown exponentially, changed in composition and is now in decline. Because of this, we believe it is an opportune time, a crucial time, to reassess the goals and purposes of county government and the means by which they might be achieved. Do the changing demographics, along with ecological, economic and technological changes suggest new, reprioritized or additional goals? Would the County benefit from different structures for support of these possible new goals? We believe a closer, more open, more imaginative look at Charter issues will benefit the County and its residents.

4. Therefore, we support the concept of the recently recommended and approved County Charter Review Commission. For this, we encourage a very open and transparent process for the Commission. The process should establish deadlines for its work that foster both thoroughness and meaningful and timely progress. All meetings should be open, invite public comment and provide timely minutes for the public's review.
5. As to the composition of this special Commission, we support representation from varied segments of the community as well as from county and town levels of government. Ideally, representation would take into consideration gender, age and ethnicity as well as those with backgrounds in various relevant fields.
6. Finally, going back to a point made earlier, communication about what is going on within, and because of, our County government needs major enhancement. This includes communication with the various media and the towns. The League will continue to do its part to keep county government on the public's radar but it will take much more than our organization can provide to create a well-informed and literate Cape Cod population with regard to the County.

## President's Report 2011

My second year as your president began with the LWVUS convention in Atlanta. Among the many things learned was that the League works hard at many levels in many places! We are a vital organization, not without problems, but an organization which continues to live its mission of citizen education, voter services and advocacy on important issues impacting all of us.

Our Area League shined in all these areas this past year. To highlight: our collaborative Civility Forum, with emphases on education and advocacy, drew a large crowd at Cape Cod Community College in September. It, in turn, was a direct influence on the level of civility at our congressional candidate forum, a voter service activity, in October. Wastewater management and county government were the subjects of our other two forums, both educational activities. We're delighted that the county government forum was the stimulus for a lengthy discussion of functioning, structure and some type of on-going charter review at a subsequent Assembly of Delegates' meeting. I feel certain we will hear (and be part of) more to come in that important area. The County is greatly appreciative of our on-going interest; we'd so welcome more members to be part of our County Government Observer Corps. Our small but loyal group is the only group which plays this important role for the County.

One of the exciting things of my and the Board's work is seeing the increase in interest and activity of members that the work of our committees and board generates. For example, the number of meetings that vice-president for program, Renate Sands, and the county government committee, Jari Rapaport and Nancy Curley from the board, plus several others, have held would tire most of us, but they remain so committed and enthusiastic. So many Board conversations when we veer off topic conclude with a suggestion that we need to have a forum on "that" subject. Program planning for 2011 – 2012 may be a challenge! We need and sincerely seek the input of all our members. Please attend May 14 and participate.

I have great praise for our nominating committee facilitated by Phyllis Walsh. The 2011-2012 board will include some new faces along with the familiar (assuming their election). We will be saying goodbye to Freddie Fitzgerald, Elaine Bono and Renate Sands who have done superb work over the years.

Sometimes the work is the nitty-gritty. Last summer three of us reviewed the By-Laws making a few not too significant changes, primarily clarifying and simplifying the language. The board approved them in February and they now await approval at the Annual Meeting. My thanks to Elizabeth Levy and Betsy Bray for their help on this project.

Debbie Aikman has been superb as treasurer, keeping us in line, offering suggestions and doing all our data entry for the LWVUS. We've kept her busy with that by the addition of twenty new members since this time last year!

What the Cape Area League is so fortunate to have is a great team spirit that produces amazing work with notable results. Thank you all,

## **UNIT REPORTS**

### **CHATHAM/HARWICH**

The subjects of Chatham/Harwich's regular meetings this past year were school regionalization and county government. In anticipation of possible Town Meeting votes in the fall on the merger of the Chatham and Harwich schools into a single regional district – a very controversial issue -- we scheduled our Unit meeting in July rather than waiting until the more usual time of September/October. Members of the combined regional school planning board attended, explaining their work and findings, answering some of our many questions and presenting some concerns of their own. It was a well-attended meeting (perhaps because we gathered in a restaurant).

Preoccupied as we were with the school issue until the November vote, (regionalization passed in both towns!) we didn't meet again as a Unit until February. This meeting, a follow-up to the League's January forum on county government, had us talking with our local Assemblymen (Ron Bergstrom, Chatham, and Leo Cakounes, Harwich), in an effort to increase our understanding of county structure, issues, and problems from the points of view of our elected town representatives to the Assembly of Delegates. In Chatham, April brought the traditional warrant meeting ~ this time, however, not with Town Manager Bill Hinchey who is departing in May for Yarmouth, but with new Finance Director, (Ms) Alix Heilala. Alix has impressed us all with her quick grasp of the many and complex issues facing the voters ~ and while we will miss Bill Hinchey, it was interesting to get a different perspective. In Harwich, a town-appointed Voter Information Committee has assumed the role traditionally filled by the League.

## **COMMITTEE REPORTS**

### **HEALTH CARE COMMITTEE**

This was a study year for the Health Care Committee. We decided to look into health care on the Cape and found that substantive changes in the way health care is provided by physicians are planned and will be implemented over the next few years.

The changes involve the development of new alliances of physicians called Accountable Care Organizations (ACOs) through which patient care will be provided. Governor Deval Patrick is a strong supporter of this concept and foresees ACOs as the solution to the increasingly unsupportable cost of the "Massachusetts Miracle" health care plan.

Our committee met in early May with the Medical Director of Cape Cod Hospital to learn how the ACO concept will work on Cape Cod with an eye toward developing a forum for next year that will present the pros and cons of ACOs to members of the Cape Cod community.

We also plan to print and distribute an updated Low Cost Health Care pamphlet prepared by one of our members this year in early Fall 2011.
